Press plays fast, loose with image of NOI's Louis Farrakhan

gaming companies address the issue of diversity, their appointments represent measurable progress. Do you recall these appointments being reported in a positive manner by either the R-J or Sun? If not, you know what score to assign, right?

A development team of African-Americans had just come together to revery effective job Commissioner Yvonne store the Moulin Rouge as a historic cultural and business site based on the fact it was the first integrated casino to open in Las Vegas.
