# U.S.: Algerian election free of voting fraud

The Bush administration characterized Algerian President Abdelaziz Bouteflika's landslide re-election as free of fraud and Algeria's first genuinely contested multiparty presidential contest.

Bouteflika won by waging an active campaign, the State Department said Friday.

The department congratulated the Algerians and praised the 67-year-old president as a friend of the United

Bouteflika won a second term Thursday with 83 percent of the vote.

The final count gave Bouteflika's challenger, former Prime Minister Ali Benflis, only 8 percent. Benflis said he would appeal to the Constitutional Council, which validates results in the Arab North African coun-

He denounced the elections as a parody and alleged that irregularities occurred "in thousands of polling stations across the country."

Secretary of State Colin Powell said during a December visit to Algiers that continued improvement in U.S.-Algerian relations hinged on conduct of the election.

Powell said then the process must include "full, fair and transparent processes" as well as fair media access for the candidates.

The elections were monitored by 128 foreign observers, 63 from the Arab League and 52 from the African

The United States sent no official election mission to Algeria.

"Our embassy officials were obviously out observing and reporting, based on what they saw," State Department spokesman Adam Ereli said Friday.

What they and the foreign observers saw evidently met with the State Department's urged the Algerian government to investigate the allegations of fraud.

"Election-day processes were generally transparent and free from fraud," Ereli said. "I think the Algerian people should be congratulated on having conducted this election in a peaceful and relatively transparent way."

It was unclear whether U.S. Embassy observers checked voting places out-

approval, although Ereli side Algiers, the capital, but the Bush administration clearly was pleased with the balloting after a decade of violence and extremist Islamic terrorism in Algeria.

There was no immediate word whether or when Bouteflika would be invited to Washington as part of the administration's ardent drive to promote moderation among the Arabs.

Algeria has lurched to-

ward democracy since 1989, when single-party rule was abolished.

In 1992, the army canceled democratic legislative elections that a now-banned Islamic party was seen as sure to win.

Many of Bouteflika's supporters said he deserved reelection because of his success in putting down the insurgents, the Salafist Group for Call and Combat.
