Granger, a Union soldier, on June 19, 1865.

"We teach children to understand the whole issue of slavery," Pollard said. "Slavery was a social and economical issue and not just about the color of our skin. There were three ways a slave could get freedom. The Emancipation Proclamation was one. Confederate slaves went to war on the side of the South and were freed. The 13th Amendment to the U.S. Constitution in 1865 ended slavery.

"We have all of these ways that slaves were free," Pollard said. "We just want everyone to be aware of this and do our part in bringing greater understanding to African-American history. It's there, but a lot of times it is not being taught."

Entertainment is scheduled for the Juneteenth Festival. Rhythm and Blues singer Marva King, who sings on albums with Lionel Richie, Jonathan Butler, Yolanda Adams and Stevie Wonder, among others, will also sing. Several local bands will perform. Children groups will

There will be vendor booths, Pollard said, featuring food and voter registration. A car will be raffled. Tickets are \$2 each for those 21 and older. Two graduating high school seniors will be awarded \$1,000 Books Scholarships that are funded by Albertson.

There will be a covered area in the park. "It's going to be a lot of fun," Pollard said. "Juneteenth in different states is really big. We are trying to grow into something special, but it takes a while to educate the public. Juneteenth is a really nice event."
