Actors Guild and now the impending strike involving hotel workers.

"Los Angeles has been home to some of the most exciting organizing campaigns in the last 10 years, which is interesting if not ironic considering Los Angeles historically has not been known as a union city," Wong said.

Unions' involvement in politics and social justice, Contreras said, was a natural progression, which occurred as more energized union leaders came into play, including Freeman.

The new batch of organizers are simply aware of the bigger picture.

"Clearly we want to broaden our scope to include more than just hours, wages and benefits," he said. "Our members' lives at home are just as important to us. We are working on safe streets, affordable housing, access to higher education. We want to make our communities better."

Politically, unions are still a strong force, with the ability to mobilize massive voting blocks. Unions are good at getting their members to walk precincts, donate funds to candidates and, in the end, go to the polls and vote, experts said. Often times, the union endorsement is the most sought-after, especially in Southern California.

"As a consequence you have people like [State Assembly Speaker] Fabian (D-Los Angeles), Karen Bass, [Assemblywomen] Jackie Goldberg (D-Los Angeles) and Judy Chu (D-Monterey Park) who were elected in large part due to labor backing, and on the City Council you have Martin Ludlow and [Antonio] Villaraigosa, both of whom worked for unions," said Wong, who has worked at UCLA's Labor Center for 14 years.

Those following the labor movement said security guards, healthcare workers, migrant farmers, childcare providers and janitors are the next wave of workers who will be targeted heavily by unions, with a focus on security, which has been one of
