Recently, renovations Indians are direct descendants of Chief Cabazon, the leader of the Desert Cahuilla Indians from the 1830s until the 1870s. Their ancestors were primarily Cahuilla Indians. Cahuilla (pronounced Kahwe-ah) means "masters" or "powerful one," and are comprised of 2 moieties and approximately twelve patrilineal clans.

The Cabazon Band of Mission Indians is a sovereign nation, recognized under the US Constitution and the owners of the property. They are also the tribe that won the landmark 1987 Supreme Court decision opening the door to Indian gaming
