(Continued from Page 4) strength of these relationships, some say, may decide the race for mayor.

With unemployment high among minorities in the city, community activists say that progressive Whites and Blacks, Latinos and Asians will be monitoring the proposed solutions that the candidates espouse.

"It's the issues, stupid," joked Bertha Lewis, executive director of the New York ACORN, an advocacy organization that focuses on housing issues.

Bryan Pufolkes, with New Immigrant Community Empowerment (NICE), agrees: "I see alliances that are forming based on issues and not necessarily strictly along racial lines," said Pufolkes.

Activists repeatedly cited economic issues-housing, health care and educationas unifying issues that will rally minorities and Whites to fight for reform.

"The main thing that you have is working people—the bus driver, the nurse, the teacher, the delivery guywho find it more and more difficult to find decent affordable housing," said Lewis.

Irma Rodriguez, associate director of a Queens multiservice agency, said class will be the uniting factor this year. "What has emerged is that it's really connected so thoroughly to issues of poverty."

Ana Maria Archila, the executive director of the Latin American Integration Center, concurred: "Sometimes it's easier to achieve solidarity under the worker umbrella than the people of color umbrella."

Added Rodriguez: "People are seeing more similarities and potential for power than just sticking with their own ethnic group," she said. "You can respect someone's cultural differences and still understand that 90 percent of your experiences and values are simi-

Andrew Friedman, of Make the Road By Walking, a Brooklyn social justice organization, said that "no significant victories for low-income, working-class communities of color can be won by any one of these communities alone."

Hence, coalition-building, he says, becomes both a means and an end: a strategy for achieving political goals and a way to unite different communities.

Coalitions across racial and ethnic lines have been forming-and have scored political and policy victories. Many have come together in support of rights, opportunities and access for immigrants. A coalition of over 120 groups, including SEIU 32BJ and the NAACP, were instrumental in getting city legislation passed that required translating and interpretation services in health care facilities.

Veronica Jung, executive director of the Korean American League for Civic Action, cited two examples of successful organizing across racial and ethnic lines. The first was the response to the brutal beating of a Sikh man in Queens last year. Latinos, Jews, Asians and Blacks joined in a rally of support outside Queens Borough

The second is the Asian Pacific Americans Voters Alliance, a coalition of 40 Asian American groups that formed last year. The coalition, which Jung called "unprecedented," registered over 7,000 new voters and conducted voter education and mobilization.

NICE's Pufolkes cited his group's campaign for noncitizen voting rights, supported by a three-dozen member coalition, including Asian and Puerto Rican groups. Several activists also highlighted the election in Flushing of the first Asian to the state Assembly.

Perhaps the greatest vic-

tory was last year's passage of an increase in the state minimum wage-over the veto of Governor George Pataki. According to activists, that issue cut across ethnic lines, bringing together unions, community-based organizations and advocacy groups.

"This was an effort that everyone understood," said Lewis of ACORN.

In a mayoral race that is likely to get heated, activists warn against the temptation by candidates to inflame racial sensibilities.

In the months leading up to the race, many groups plan to conduct non-partisan voter registration, and education and mobilization for this year's election, making sure that the issues that unite them are on the political agenda and that candidates, whatever their race or color, are forced to respond.

And some are at least a bit the Amsterdam News.

optimistic.

"If there's going to be a rainbow coalition, that has been talked about for years and years and years," said Lewis. "The moment has finally come."
