Glover brings talented feet to LV

Ten minutes into the Savion Glover show, "Improvography II," I found out just how narcissistic and how Vegas I really am. I came to the show expecting, as one does in Vegas, to be entertained by Glover. So, imagine my surprise as he took to the stage with no big over-the-top Vegas introduction and simply began to demonstrate his genius. The narcissistic part of me was a bit miffed. I mean this is Vegas, right? But Savion Glover is about as Vegas as a snowy day in June.

Dressed simply in a lime green shirt and tuxedo pants, Glover is quite simply a tap virtuoso. After getting over myself and immersing into the Savion experience, I began to appreciate the opportunity to witness a genius at his craft. "Improvography" is the latest production that Savion Glover brings to the stage. Set against a background of nothing more than a Black backdrop, simple lighting and the stunning jazz ensemble of Tommy James, Brian Grice, Patience Higgins and Andy McCloud, "Improvography" is the type of performance that you can't quite call a show, but you understand that it is.

Directed and choreographed by Glover, "Improvography" is a twoact performance that opens with a surprising vocal number by Glover and a 45-



group presentation that included the dance troupe Chapter IV, composed of Maurice Chestnut, Ashley DeForest and Cartier Williams. The solo performance is where the show excels. Glover forces you as an audience member to focus and

minute solo followed by a concentrate on the lightening speed of his feet and the power that he uses as he taps. He very rarely, if ever, looks at the audience giving the impression that he may be extremely shy. In truth, he is so focused on the music and what's happening on the stage that what you may be-

lieve to be shyness is his total concentration on the music, the musicians and his own two feet.

As much as he commands what's happening on the stage, there is a point in the show, however, where I watched him enter his zone and forget everything except his desire to dance. With a small smile on his face, he closed his eyes and gave himself up to his craft and gifted the audience with his pure and unadulterated love of tap.

The show falters a bit in the second set which follows a short intermission. Coming back on stage in a red shirt and blue jeans, Glover comes on stage with the dance troupe Chapter IV, and it almost feels as if he is teaching a class rather than performing in a show. For all of his choreography talent, Glover should remove himself from this portion of the performance and allow the dance troupe to perform on their own. His talent drowns the young dancers and causes an unnecessary comparison of him to the other dancers. Luckily though, he commands the stage alone before the show ends and brings the performance back to the level of genius.

Lore has it that Glover started taking classes at the Broadway Dance Center in Manhattan wearing Thom McAn cowboy boots because his mother couldn't afford tap shows. Glover has come

LOS ANGELES - A judge has ordered Marion "Suge" Knight to pay \$107 million to a woman who claims she helped the rap mogul start Death Row Records, ruling Knight and his attorneys failed to answer questions and provide information in the case.

Superior Court Judge Ronald M. Sohigian ordered Knight and his companies, including Tha Row Inc., to pay Lydia Harris, who claims she is owed money from the recording label she helped establish.

She is married to Michael "Harry O" Harris, an imprisoned drug dealer, who has claimed he put up \$1.5 million from behind bars in 1991 to help start Death Row Records. Knight has repeatedly denied that contention.

The judgment includes \$60 million in punitive damages, \$45 million in economic damages and \$2 million in noneconomic dam-

The judge issued the judgment earlier this month after finding that Knight and his attorneys violated court rules requiring them to answer questions by and providing information to Harris and her attorneys.

A phone call to a Knight attorney seeking comment was not returned Wednesday.

In her 2002 lawsuit, which didn't reach trial, Harris claimed she and Knight in 1989 became equal founding partners of Death Row Records. When Knight realized how lucrative the label would become, he pushed her out, Harris claimed.

Harris said Knight defamed her in hopes of destroying her credibility in the music industry and with new

"His conduct made it clear that he did not intend to honor his agreement or pay

the shares of profit due her," said her attorney, David Casselman. "He also publicly insulted her and falsely accused her of promiscuity and incompetence."

Knight has had a series of legal and criminal troubles.

In 2003, he was ordered to pay \$5.5 million to managers of artists who accused

him of stealing one of their

Knight was released from prison in 2001 after serving time for assault and weapons violations. He recently served an additional 10month prison sentence for violating his parole and striking a Hollywood nightclub
