# **PUBLIC COMMENT PERIOD**

PROPOSED TRANSPORTATION PLAN **CONFORMITY ANALYSIS** 

The Regional Transportation Commission of Southern Nevada (RTC), the designated metropolitan planning organization (MPO) for the Las Vegas Urban area, is proposing to issue a Finding of Air Quality Conformity for the 2004-2025 Regional Transportation Plan (RTP)

The RTP for FY 2004-2025 was adopted in June 2003 and amended (Amendment #1) later that year. A Finding of Air Quality Conformity on the amended Plan was accepted by the US Department of Transportation on March 17, 2004. A new Finding of Conformity is required because most of Clark County has now been designated by EPA as a non-attainment area for Ozone. A conformity analysis has been conducted by the RTC based on the projects listed in the approved RTP and its 1" Amendment: These documents can be viewed at or obtained from the RTC Administrative Building at the address below. This analysis demonstrates that implementation of the projects included in the RTP will not have a negative impact on air quality. Based on this analysis, the RTC has concluded that the RTP for FY 2004-2025 is in conformity for Ozone and remains in conformity for Carbon Monoxide and PM, (particulate matter 10 microns or less).
