# Are sports officials really fair? CLASSIFIEDS

As long as there is competition in a variety of sports around the world, the questions often arise about the integrity of sports officials and controversy regarding the final outcome.

Everyone recognizes officials as human beings who are subject to errors in judgment like others in daily life. But when the winners' hands are raised, the doubting are not convinced the right person or persons deserved the victory.

The latest historic controversy occurred Saturday evening at the Mandalay Bay Event Center at the conclusion of the lightweight title bout between Diego Corrales and Jose Luis Castillo. The final outcome goes on record as a technical knockout by Corrales, but the ending was the beginning of another controversy.

During the tenth round of the highly contested bout, Castillo floored his opponent twice. Each time, Corrales got up after taking a count from referee Tony Weeks. The two battlers continued after the first knockdown. Then Corrales went down

While on the canvass the second time, Corrales took his mouthpiece out and threw it on the deck. In some cases, this would have been a sign of submission and the bout would have been over, but it wasn't as Weeks picked up the mouthpiece and gave it to Joe Goosen, Corrales' trainer, who washed it off and placed it back in his fighter's mouth. Both fighters rested during that brief intermission.

When the fray continued, Corrales, who had been fighting with his left eye almost closed, landed a hard right that stuns Castillo, who is driven back onto the ropes from the blow. Sensing his opponent's dilemma, Corrales unloaded five to six unanswered punches. Referee Weeks stepped in and stopped the fight declaring Corrales the winner. Castillo's supporters were furious about the stoppage and attempted to protest to no avail.

"I stopped the fight because he (Castillo) was out on his feet," Weeks said when interviewed after the fight.

Castillo said, "I was not knocked out and should have been given a chance to con-

When he was asked about a rematch, Castillo, who had a cut on his left eye and whose face was swollen answered, "Manana," which drew laughter from those assembled at the post fight press conference."

When he was interviewed immediately after the fight, Corrales denied throwing his mouthpiece away after the second knockdown. But all who were watching, along with Weeks said the fighter deliberately took it out of his mouth and threw it down. He claimed it slipped as he was trying to replace it. A furious Bob Arum, the Top Ranks boxing promoter, said the replacement of the equipment took 28 seconds and frowned on the length of time and also said Corrales should have been required to continue without the mouthpiece according to boxing rules.

Both fighters were resting during that time frame. So, Castillo wasn't denied a chance to get his wind back either. In retrospect, Castillo just got careless. Probably because he thought Corrales was finished and the fight would be over in few seconds, and he would be declared the winner, so he let his guard down.
