With Golota win, Lamon Brewster flying high

World Boxing Organization's Heavyweight boxing title Saturday at Chicago's United Center, champion Lamon Brewster's chances of winning against challenger Andrew Golota were considered slim or just plain none.

The odds posted by the Las Vegas casinos were Brewster plus 200 and Golota minus 250, which meant betting \$100 on Brewster would win \$200 dollars plus the bet amount back, and a bet on Golota would only net \$250 total. The odds makers had the fight 12-5 for the challenger the day of the fight.

Although Brewster had 32 wins, two defeats and 28 knockouts, his previous



bouts, which included the stoppage of former WBO champion Wladimir Klitschko in five rounds and a controversial split decision against former sparring partner, Kari Meehan, Brewster's skeptics thought he was out of his class taking on the rugged Polish challenger.

Golota, a 37-year-old battler, who had given former undisputed Riddick Bowe a beating before being disqualified in both bouts, held a record of 38 wins, six defeats and one draw, was making his fourth attempt to win a title after experts thought he had beaten World Boxing Association champion John Ruiz in their bout a few months earlier.

While training here at Barry's Boxing Gym before the bout, Brewster, when interviewed said he had a plan to win the fight but would not reveal it to the reporter.

The Indianapolis, Indiana, native Brewster who currently resides in Los Angeles, said, "Fighting in the swimming pool that I love,

to be anything but fireworks, from the beginning to the end, if there is a end...if it goes 12 rounds."

He said the bout against a formidable opponent like Golota gave the transplanted Indianan a chance to make history because there hadn't been a heavyweight title bout in the Windy City in 24 years. He said he was hoping to follow the pattern of Muhammad Ali, who said that in order to be great, you have to fight good opposi-

"I could fight bums, but what does that say about me?" Brewster said, quoting his hero Ali. "Golota isn't a postal worker or a dude off the street. He's made a name for himself, so if I beat him,

Chicago, there aren't going I will have established myself as a pretty fair fighter," Brewster explained.

> Brewster said he even prayed each day and read the Holy Bible to give him strength to come out victorious in his bout with Golota.

> Prior to the bout, being from Indianapolis, Brewster has been chosen as the man with the green flag to start this year's Indianapolis 500 IRL race this Sunday.

> He must take his scheduled announcement of, "Gentlemen and lady start your engines," seriously, because after stripping down to his camouflage boxing trunks and hearing the opening bell, he jumped on Golota like a college boxer on a scholarship at the University of Nevada Las Vegas. He started his engine early. Nicknamed "Relentless," Brewster was just that.

> Before Golota could land one punch, he was down on his back. When he arose, Brewster, taking a page from Jack Dempsey and Luis Firpo, knocked the Pole through the ropes. With some assistance, Golota arose again, only to face another onslaught by Brewster and went down again. The referee stopped the bout with the challenger looking very perplexed.

The bout was over in 53 seconds of the first round and Brewster, who idolizes Iron Mike Tyson, had given his imitation of his idol's quick

was in his prime.

Brewster, who leased a house in Las Vegas to train, has given some thought to moving here permanently to be near his relative, Chris Byrd, the International Boxing Federation champion, and other local resident fighters -John Ruiz, the WBA champion, and Hasim Rahman, who has a chance to be the interim WBC titleholder, if he defeats Monte Barrett on July 23 in Madison Square Garden.

With the possibility of a heavyweight champions tournament, Brewster's latest performance would rate him high on the list of becoming the next undisputed heavyweight champion of the world.

Vitali Klitschko, considered the Ring magazine heavyweight champion, is recovering from back surgery and will not be fighting until at least September 2005.

Meanwhile, Brewster said, "God said I will never forsake you. If you stand, I will fight. Coming from the bottom, I did not give up. I didn't really have a plan. I had an objective... to be the undisputed heavyweight champion of the world.'

But standing in his way is cousin, Chris Byrd. "My mother's maiden name is Byrd. I have to think about that fight, But it is all about money. So, we will see what will happen in the future. Don King is the promoter and tells everyone what to




