step up and help this family as well as help organize the activities to keep the awareness around [Suzie's] death."

People like Ali and Ybarra have faith that a coalition can be achieved despite the many obstacles they see. Whether it be outside forces preventing the formation of a powerful, politically active partnership, or opposition from within, there are those who see a bright future in collaboration.

Both Blacks and Latinos are suffering from similar ills, so by joining together many believe their voices can become stronger and make more of an impact.

"In order for this child's

life to really mean something, we have to understand why this happened," Tim Watkins, director of the Watts Labor Community Action Committee, said.

"All of the problems that occur in Watts and the surrounding areas have to do with the pressure of everyday life that results from poor public policy. I think that all of us, myself included, have referred to residents of Watts as poor people and by doing that we put a label on them that sticks with them.

"They are not poor people," Watkins added. "They suffer from poor public policy. I'm sick of the world outside of Watts thinking we do not have the intel-

lectual capacity to represent ourselves. Nothing could be farther from the truth.

"We have an opportunity for Black and Brown to come together now, and we must not waste this opportunity."
