## Jackson condemns FEMA, stumps for aid

At a press conference held Tuesday afternoon in North Las Vegas, Rev. Jesse Jackson Sr., Rainbow/PUSH coalition founder, began his 41state tour to make communities aware of the Federal **Emergency Management** Agency's announcement that it would soon stop paying motel and hotel bills for hurricane evacuees in many states.

He stressed the urgent and ongoing need for federal aid for disaster victims of the Gulf Region.

The press conference was held at Holy Trinity Church and attended by representatives of local churches and community organizations, including Clark County-Las Vegas Urban League and the NAACP.

Jackson was one of the first national leaders to go to the Gulf Coast region in the

immediate wake of Hurricane Katrina, and he remains dismayed by federal and FEMA response to victim's

Jackson is advocating for more federal attention to the needs of the evacuees, especially affordable housing and assistance with relocation back to their home area.

He condemned the FEMA decision, which has since been rescinded, to cease funding for emergency housing for most Katrina survivors effective Dec. 1.

The initial plan to cut off emergency subsidy for hotels and motels, Jackson said, would have resulted in thousands of families being suddenly homeless during this holiday season.

"It will make a disaster out of disaster relief efforts," he stated.

On Wednesday of this week, supporters were scheduled to march on the governor's Los Angeles office. On Sunday, Dec. 4, there will be a candlelight vigil as part of a 'National Day of Action' to stop the execution of Stan Tookie Williams.

Williams, a co-founder of the Los Angeles Crips street gang, is slated to be executed on Dec. 13 in San Quentin state prison. During the 1990s, he wrote a series of award-winning books for children, warning against gangs, crime and prison which earned him a nomination for the Nobel Peace

He was convicted by an


all-White jury for the murders of four people in 1979 during two separate robber-

In his original trial, the

main evidence against Williams was the testimony of jailhouse informants who appeals courts have admitted had "an incentive to lie in

order to obtain leniency from the state."
