Norma Miller "swings" at WLV Arts Center

Legendary swing dance performer Norma Miller, former member of the internationally renowned Lindy Hoppers directed by Herbert "Whitey" White, will be performing at 6:00 p.m. Friday at the West Las Vegas Arts Center located at 947 West Lake Mead Blvd. Miller began her dancing career with the Lindy Hoppers at the age of 14, being the youngest member of the group.

Prior to joining the group, Miller danced outside the Savoy Ballroom in Harlem, New York, where she grew up and learned the style of swing.

She won the Apollo Theatre lindy hop contest in 1934, leading up to her joining the Lindy Hoppers, along with winning the Harvest Moon Ball contest in 1935 and being invited to tour in Eu-

The lindy hop was one of many variations of swing ballroom dancing electrified by contemporary jazz music.

From the beginning Miller was considered to be a creative dancer and continues to this day to possess an outstanding sense of rhythm.

After leaving the Lindy Hoppers in the 1940s, Miller created her own company in Los Angeles, Calif., and per-

formed at Club Aabam in Watts.

Miller is also known for being a comedienne, and she worked with Redd Foxx for over ten years and appeared in segments of "Sanford and Son" as

an airlines stewardess delivering the following, "Coffee, tea, or me?"

Commenting on her upcoming performance, Miller stated,

"I have been involved in performing and teaching swing for a long time, and I was one of the first Black shows to tour Las Vegas playing at the El Cortez. From there, I performed here again with the Count Basie Orchestra."

She added, "I was very successful with the 'Whitey Lindy Hoppers' and went on to establish my own Norma Miller dancers group and jazz group. I expect to showcase a film presentation of my career, because I'm a storyteller, and I provide a story about swing danc-

Miller has performed in many films including "A Day at the Races" and "Hellzapoppin" along with appearing at the 1939 New York World's Fair. Two of her last projects included appearing in the Spike Lee's film "Malcolm X" and in Debbie Allen's television film "Stomping at the Savoy."

She is the author of "Swinging at the Savoy," a book described as presenting a definitive account of the early days of swing. In March 2006, her life story in film was featured at the Smithsonian Institute.
