# Bonds' feats deserve to be honored

When San Francisco leftfielder Barry Bonds' fly ball sailed over the fence at AT&T Park last Sunday for homerun number 715, he placed two African-Americans on the top of the records list 59 years after another player, Jackie Robinson, made history by opening the major leagues for them to play alongside their fairskinned, White counterparts.

On April 15, 1974, after receiving an enormous amount of hate mail, Henry "Hank" Louis Aaron, playing for the Atlanta Braves, surpassed the record of George Herman "Babe" Ruth with the 715th home run on a pitch from the Los Angeles Dodgers lefthander, Al Downing both African-Americans.



Since then, many have wondered if the pitch down the middle was a setup job or just a bad pitch and a good hitter.

One thing for sure, Byung-Hyun Kim, the Korean pitcher who goes into the record books as the 421st pitcher to become a homerun victim of Bonds, was doing his job and had a 3-2 count and was probably hoping for a strikeout instead the hitter's 715th homerun.

And moving into second place on the homerun list behind Aaron's 755 in front of the sellout crowd of 42, 935, was just what Bonds had been hoping to do ever since this season began in San Diego on April 3. He started with 707 and hit 714 in Oakland last week.

Bonds, born on July 24, 1964, was almost 10 years old when Aaron parked his homerun in the bullpen at Atlanta's Fulton County Stadium, and although young Bond's was witnessing history, the history-making impact didn't really occur to him most likely.

Aaron probably hadn't set Babe Ruth's homerun record as his goal when he signed with the Milwaukee Braves in 1954 after becoming a player in the major leagues at only 20 years of age following a stint with the Indianapolis Clowns in the Negro

Aaron hit 44 homeruns in 1957, and for most of his 23year career, he was one of the most feared homerun leaders in the major leagues while playing for the Braves and returning to Milwaukee before retiring in 1977.

He left the Braves with only 733 homeruns, adding 22 more when he went into the American League.

He ended his career with a .312 batting average, 755 homeruns, and 2,202 runs bated in and played in 12, 364 games.

And although 41 homeruns are needed by Bonds to overtake Aaron at the top of the list, there is some speculation over whether Bond's injury-ridden body - three knee surgeries and bone chips in his elbow - would allow him to add any more seasons to his 20-year career.

The FBI tried to trap Bonds on charges of steroid consumption, but no matter what the final outcome of an investigation by the league, sports analyst John Kruk, a former major leaguer, said it best, "Hitting 715 homeruns is quite an accomplishment."

He should know because he was at one time one of the most feared hitters in the National League when he played with the Philadelphia Phillies.

Bonds said he didn't knowingly take steroids. The

Bonds broke McGwire's

mark of 70 by hitting 73 in

"I'm just wondering how much longer he can do it," Atlanta pitcher John Smoltz said. "He's the greatest - in my era - home run hitter I have ever seen."

Bonds was limited to 14 games in 2005 following three operations on his troublesome right knee, and Alou believes the seven-time NL MVP is still finding his groove at the plate because of a shortage of at-bats during spring training.

While Bonds hinted recently Aaron's mark might be out of reach, he sounded more upbeat Sunday, saying "If you keep playing long enough, anything's possible."

Another of his former managers was eager to congratulate the slugger.

"Nobody has a number to get to Barry, that's No. 1," said Cubs manager Dusty Baker, Bonds' skipper for 10 seasons with the Giants. "I called a couple of people and told them to deliver a message for me. That's quite an accomplishment, a tremendous accomplishment."
