The report concluded that the U.S. Justice Department has investigated more than 600 incidents of backlash since the 9/11 attacks and won convictions against 22 of the 27 defendants that it chose to prosecute.

"We believe the biggest factor contributing to anti-Muslim feeling and the resulting acts of bias is the growth in Islamophobic rhetoric that has flooded the Internet and talk radio in the post-9/11 era," said CAIR Legal Director Arsaian Iftikhar, the report's author. "Islam-phobia" is reflected in the negative images and buzzwords that produce stereotyping, physical and verbal attacks, along with racial profiling of Muslims of color, including Muslims of African descent.






