what she described as "beyond what I could actually call a friend."

She said they still talk on the phone every week and Cotton recently attended her daughter's soccer game with his own daughter. She said she is now close to a man who she once wished dead and who, a few decades ago, could have been executed for a crime for which he was wrongly convicted.

"He literally is the person who taught me on that afternoon in 1997 about forgiveness, about mercy, about grace," said Cannino.

Wake Forest ethnic studies professor Earl Smith was also a panelist, along with North Carolina Coalition for a Moratorium campaign coordinator Jeremy Collins and Tina Walker, whose half-brother was executed.

Walker lobbied unsuccessfully against her brother's execution. Steve McHone, her half-brother, was convicted of murdering Walker's father.

Her stance for McHone was controversial in her fam-

ily. Most of her kin have disowned her. Walker said she eventually came to forgive McHone and visited him on death row. She credits the movie "Dead Man Walking," based on the real life death row ministry of Sister Helen Prejean, for helping to inspire her actions. She now advocates for the abolishment of the death penalty.

"I think the only win-win is through forgiveness and stopping the execution and allowing the healing process to continue, because execution stops the healing process," said Walker.

Collins said his coalition advocates for a moratorium on the death penalty while reforms are put in place, such as making it so that only those convicted with DNA evidence can be executed. He said that the ultimate punishment deserves the ultimate scrutiny and the coalition wants the death penalty's application narrowed.

The key to getting a moratorium in North Carolina, he said, is educating people about the subject and getting them to lobby their legisla-

tors about it.

Hunt said the criminal justice system is flawed and it's up to the next generation, such as college students, to eliminate the racism and injustice within it.

He said people talk about being good and forgiving others but don't practice those things when it comes to the death penalty.

"We talk about it, but we don't live it," said Hunt.

The panel was organized by Dowd Keith, a theater major at the university. It was held in conjunction with "Life by Asphyxiation," a Kia Kia Corthron play that Keith directed at Wake earlier this week.

Keith hoped the forum would shed light on themes of the play, which centers on justice and the death penalty.
