than words."

The Lakers won championships from 2000-02 and reached the NBA finals again in 2004, losing to the Detroit Pistons in five games. The

team was broken up at that time. O'Neal was traded, Jackson left and other stalwarts — Karl Malone, Gary Payton, Derek Fisher, Robert Horry and Rick Fox — went elsewhere or retired.

The Lakers failed to make the playoffs the following season. With Jackson returning before the 2005-06 campaign, they finished seventh in the Western Conference in each of the past two years, but were eliminated by Phoe-

nix in the first round of the playoffs.

The Lakers appeared to be title contenders through the first half of this season, going 26-13 despite several injuries. But they lost 27 of their last 43 games to finish

42-40 before bowing to the Suns in five games.

Bryant urged the team at season's end to do what it

takes to get back into contention. He repeated those comments last weekend in an interview with the Times.

Transportation Planning Certification Review of the Regional Transportation Commission of Southern Nevada Public Meeting - June 6, 2007
