Miller's endorsement of Clinton was not unexpected. The centrist Democrat, who served 2 1/2 terms in the 1990s, was state chair of President Bill Clinton's 1992 and 1996 presidential campaigns.

Now a principle in a lobbying firm, Miller will co-chair the campaign's national Governors Council.

Miller described Clinton as competent and compassionate. "When you can be with her in a smaller setting," Miller added, "people warm to her because she warms up to people," he told The Associated Press in advance of his formal endorsement last week.

The effect of such endorsements in Nevada's first early caucus, slated for Jan. 19, is still unknown.

Political experts said such backers are most useful if they bring access to donors and grass-roots networks crucial to winning a caucus.

Support from key insiders also can help build a coalition within the party and project an air of inevitability, said Fred Lokken, political science professor at Truckee Meadows Community College in Northern Nevada.

"You have to have some establishment support in a caucus or a primary," Lokken said. "You can have a lot of people supporting you, but if they don't participate in the process, you are not going to get to the place you want to get to."
