cut their teeth. The Chitlin Circuit, they say, gave the Westside Blacks a platform, a voice and a way to survive.

The Westside played an extremely pivotal role in the city's race relations. The Moulin Rouge, opened for six months in 1955, was the first interracial casino in town, perhaps in the nation. The Rouge was a happening spot for revelers looking for something to do after the dinner and the midnight shows at Strip and downtown properties. The Rouge and other Westside nightclubs had third shows-breakfast show/after hours show-that attracted customers of all stripes and skin tones. Perhaps more important, the hotel-casino was the site of meeting with city leaders to desegregate the Strip. Dr. James McMillan, NAACP's then-president (now deceased) brokered the agreement with city officials who were concerned he'd make good on a threat to march on the Strip. On March 25, 1960, politicians, gaming operators, restaurant owners and organized crime caved, ending segregation on the Strip.
