# Prosecutions going forth for New Orleans suspects

NEW ORLEANS (AP) -The number of suspects set free because of delays by the prosecutor's office has dropped dramatically since the departure of Eddie Jordan as district attorney, officials said recently.

Orleans Parish, where crime has soared after Hurricane Katrina, released about 2,000 suspects of crimes ranging from drug possession to murder in 2006 and 2007 because the district attorney's office didn't indict them within 60 days of arrest.

The number of such releases in January 2007 alone was 580. That number fell to six in December, just weeks after Jordan was forced out. Black district attorney, resigned after a multimilliondollar judgment was awarded to 36 White or Hispanic employees in his office who alleged they were fired and replaced by Blacks. He had already come under fire as high-profile cases fell apart, veteran prosecutors left, and the crime rate soared.

Although the police superintendent, Warren Riley, and Jordan's replacement, Keva Landrum-Johnson, downplayed the role of the leadership change, Riley did say Landrum-Johnson was the difference.

ment, a vote recount and a new poll as possible options to end a crisis that has dented Kenya's reputation for stability in volatile east Africa.

Kenya is an ally in the United States' war on terrorism and has turned over dozens of people to the U.S. and Ethiopia as suspected terrorists.

The country allows American forces to operate from Kenyan bases and conducts joint exercises with U.S. troops

Washington said the top U.S. African envoy sent to Kenya, Jendayi Frazer, spoke to Kibaki about the move.

"The perception was he was trying to put in place a political fait accompli," U.S. State Department spokesman Sean McCormack told reporters. "We expressed our displeasure; we were quite disappointed by the action."

Kibaki told Frazer the step was intended only to keep the government running while there was a negotiated political settlement to the crisis, McCormack said.

The U.S. also is a major donor to Kenya, long seen as a stable democracy in a region that includes war-ravaged Somalia and Sudan. Aid amounts to roughly \$1 billion a year, said U.S. Embassy spokesman T.J. Dowling.

U.S. presidential candidate Barack Obama - whose late father was Kenyan - called Odinga to urge a peaceful resolution. Obama spokesman Robert Gibbs said the senator spoke to Odinga Monday afternoon for about five minutes before going into a rally in New Hampshire

Odinga said on British Broadcasting Corp. radio that Obama's father was his maternal uncle, and that Obama called him twice "in the midst of his campaigning ...to express his concern and to say that he is also going to call President Kibaki so that Kibaki agrees to find a negotiated, satisfactory solution to this problem."

According to a Kenyan government website, Kibaki won 4,584,721 votes or 47 percent of the ballots cast, against Odinga's 4,352,993, or 44 percent. However, even the chairman of the country's electoral commission has said he is not sure Kibaki won. Frazer also said that the vote count at the heart of the dispute was tampered with and both sides could have been involved.

Odinga's party won 95 parliament seats and Kibaki's party 43 in legislative elections held the same day as the presidential elections, meaning it will be difficult for Kibaki to govern without making some overture to Odinga

Odinga rejected Kibaki's recent invitation to talk, saying it was "public relations gimmickry" and that Kibaki was "trying to deflect attention from and undermine" international

Martha Karua, who has just been reappointed as justice minister, said the opposition should take its complaints to the courts. "I am certain they have no evidence upon which a credible court can nullify a Kibaki win," Karua said.

President Bush and British Prime Minister Gordon Brown offered support to the AU effort.

A group of four former African heads of state met with Kibaki and Odinga in separate meetings this week.

Now, more than a year after the defendant, a Black garbage man, was convicted of stabbing to death a White fashion writer on Cape Cod, the judge has taken the highly unusual step of summoning the entire jury back to court next week to testify publicly about whether racism infected the deliberations.

Depending on what he finds out, the judge could order a new trial.

Questioning jurors in open court about their deliberations after a verdict is extremely rare. Jury deliberations are considered almost sacrosanct.

"It's extraordinary," said Jonathan Turley, a law professor at George Washington University, who warned that forcing jurors to testify could have a chilling

"The jury system depends on jurors being open and frank in their views. We protect the sanctity of the jury room for that reason," he said.

Christopher McCowen, 34, was convicted in November 2006 in the rape and fatal stabbing of Christa Worthington, 46, a writer who had covered fashion in New York and Paris before moving to the small town of Truro.

McCowen, who was Worthington's trash collector, claimed that he had consensual sex with her but that his friend killed her.

Race permeated the case from the first day of the trial, when McCowen's attorney, Robert George, accused authorities of focusing unfairly on McCowen.

"It's based on an assumption — a false assumption - that a Vassar-educated, 46year-old, world-traveling, wealthy heiress could not possibly have had consensual sex with a Black, uneducated, troubled garbage man," George said.

The jury initially reported a deadlock but convicted McCowen two days later, (See Attitudes, Page 11)
