Patriots' Moss denies lady's battery allegation

FOXBOROUGH, Mass. (AP) - Randy Moss joined the Patriots this season determined to avoid off-field problems. Now he's in the middle of one, just days before Sunday's AFC championship game.


A temporary restraining order was issued Monday requiring the star wide receiver to stay at least 500 feet from a woman who alleged he committed "battery causing serious injury" to her at her Florida home on recently.

Moss denied the allegation by Rachelle Washington, which he called "this situation of extortion," and said he was "furious" about it. The restraining order was issued in the Broward County 17th Judicial Circuit of Florida. No criminal charge has been brought.

A hearing on whether to issue a permanent restraining order is scheduled for 3 p.m. Jan. 28, six days before the Super Bowl.

Moss broke his usual midweek silence as he was surrounded by two dozen reporters and 10 video cameras at his locker on Wednesday. He didn't identify the woman but said she has been a friend for 11 years and that she asked for "six figures" for what he said was an accident in which she was hurt.

"I want to make somemy whole entire life of living 30 years, I've never put my hand on one woman, physically or in an angry manner."

criticized by quarterback Daunte Culpepper and others for leaving the field with 2 seconds left in a regular-season loss to Washington. He bumped a traffic control officer with his car in 2002, verbally abused corporate sponsors on a team bus in 2001 and squirted an official with a water bottle in 1999.

Moss faced misdemeanor charges after a 1996 fight with the mother of his daughter, but they were dropped after both agreed to undergo counseling sessions.

He said the allegation will not distract him in Sunday's game against the San Diego Chargers.

"Last Friday, this man wanted to come out with it," Moss said, apparently referring to someone siding with Washington, "just to try to



Complaint withdra against 'Pacman' Jones

NASHVILLE, Tenn. (AP) - Authorities in Georgia say a woman who accused suspended Tennessee Titans cornerback Adam "Pacman" Jones of hitting her has withdrawn her petition to have him arrested.

A clerk in the Warrants Division reports that the petition of Wanda S. Jackson has been withdrawn.

Neither Jackson nor Jones' attorneys immediately returned calls seeking comment. Jackson, an attorney, said in her filing that she was in the Body Tap strip club's office recently when an angry Jones accused managers of stealing his money and bracelet.

Jackson said she was watching the confrontation when Jones "sucker punched" her.

Last month, Jones pleaded no contest to a disorderly conduct charge related to a strip club shooting in Las Vegas that left club manager Tommy Urbanski paralyzed.

Jones has been arrested six times since being drafted sixth overall in 2005, including two arrests in Georgia in 2006 that the Titans did not learn about until 2007. Jones was suspended for the 2007 season by NFL commissioner Roger Goodell in April.

Jones was allowed to go to the Titans' headquarters once their season ended with an AFC wild-card loss in San Diego on Jan. 6. The NFL plans to review his status following the Pro Bowl.
