## Woman cites bias pageant's lawsuit

LOS ANGELES (AP) - A Hispanic woman who won the Miss California USA contest only to have her crown yanked days later sued the pageant for half a million dollars, alleging rigging and racial bias. The pageant director rejected the claims, saying winners during his tenure have been some of the pageant's most racially diverse ever. Christina Silva, 24, was crowned Miss California USA on Nov. 25. Three days later, the pageant's executive director, Keith Lewis, told her "there has been a mistake and you are not the winner," according to the lawsuit filed in Superior Court.

Raquel Beezley, 21, was subsequently crowned.

Silva is of Ecuadorean and Mexican descent. The lawsuit claims Lewis was "uncomfortable with the fact that Miss Silva spoke Spanish with certain vendors; he felt that it may detract from the caliber of the pageant and some of the 'all American girls' may not opt to compete in the following year."

Silva alleges that Lewis, the pageant, its producer K2 Productions and the Miss Universe Organization engaged in fraud, negligence, breach of contract and intentional infliction of emotional distress, among other charges.

Lewis told The Associated Press the allegations of racial bias were unfounded. "I've had three winners since I've been a director," Lewis said. "Two have been African-American, two of four in the history of the state pageant. And the current Miss California USA is 25 percent Filipino," Lewis said, referring to Beezley. "I think my record speaks for itself."

Miss Universe spokeswoman Lark-Marie Anton declined comment. The lawsuit seeks \$500,000 in damages for public humiliation and lost prizes.

accept some restrictions on family planning groups participating in AIDS programs. Conservatives, concerned that money might be diverted to abortion promotion, pushed for a provision that allows the use of funds for HIV/AIDS testing and counseling services in those family planning programs supported by the U.S. government.

A measure in the 2003 act requiring groups receiving funds to have a policy explicitly opposing prostitution and sex trafficking, opposed by some health groups as impeding efforts among sex workers, was also left intact.

The White House, which originally promoted doubling the program to \$30 billion, has expressed concern over the \$50 billion figure but not opposed it.

Some conservatives still objected. "This is irrational generosity," said Rep. Dana Rohrabacher, R-Calif., saying the country doesn't have enough money to help veterans and the elderly. "This is benevolence gone wild."

The bill authorizes \$10 billion a year, or \$50 billion through 2013. Of that, \$41 billion is for AIDS prevention and treatment, \$4 billion for tuberculosis and \$5 billion for malaria. The actual dollars still have to be approved in annual spending bills, but over the last five years Congress exceeded the \$15 billion goal, appropriating \$19 billion for global AIDS and related programs.

The \$41 billion includes up to \$2 billion a year for the international Global Fund to Fight AIDS, Tuberculosis and Malaria. The bill limits U.S. contributions to the Global Fund to one-third of total contributions.

It expands the program, originally focused on 15 mainly sub-Saharan African countries, to include Caribbean nations as well as Malawi, Swaziland and Lesotho in Africa. The goal of the next five years is to prevent 12 million new infections, provide anti-retroviral treatment for 3 million, and train more than 140,000 healthcare workers. The bill increases coordination with drinking water and nutrition programs and efforts to educate girls and women.

"This will be remembered as the single most significant achievement of President Bush's two terms in office," said Rep. Donald Payne, D-N.J., chairman of the Foreign Affairs subcommittee on Africa.

attended by Republican Senators Mitch McConnell and Jim Bunning.

The pageant tried to showed off its edge, featuring a grinding live rock performance by the band Finger Eleven, music from Rihanna, and contestants in barely there Black bikinis and fauxfur coats.

Miss USA contestants are scored in three categories: swimsuit, evening gown and interview. Miss Alaska USA, Courtney Erin Carroll, was chosen "Miss Photogenic USA" based on voting at the organization's website. The other contestants named Miss Ohio USA, Monica Day, "Miss Congeniality." Unlike the rival Miss America, Miss USA contestants are not asked to perform a talent.
