WASHINGTON (AP) -Dwayne Giles complains that his former girlfriend's statements should not have been used against him at his murder trial because the woman couldn't be cross-examined.

Her absence wasn't a result of a scheduling conflict. She was dead. And Giles killed her.

Three California courts that have considered Giles' claim have said, in effect, "You must be kidding."

Now, though, the Supreme Court, in arguments Tuesday, heard Giles' case to see whether the use during his trial of statements the girlfriend made to a Los Angeles police officer violated his constitutional right to confront witnesses against him.

The issue the court has agreed to resolve is when defendants forfeit that right. It is already clear that a defendant who kills someone to prevent him from testifying may not come into court and seek to exclude prior statements by the dead person.

But this case is one in which there were no charges pending against Giles when he shot Brenda Avie dead with a 9-millimeter handgun outside his grandmother's house in September 2002.

A few weeks earlier, Avie told a police officer that Giles assaulted and threatened to kill her. The officer testified

about the conversation at Giles' trial, over his lawyer's objection.

Giles claimed he acted in self-defense, fearing that Avie was armed. She wasn't. Giles also testified that Avie behaved erratically and threatened to kill both him and his new girlfriend on the night she died.

first-degree murder and sentenced to at least 50 years in

California courts upheld the conviction, saying that when a witness is unavailable because of the defendant's actions, it doesn't matter whether there was an intent to prevent testimony.

lagging in home ownership rates - still much more likely than other groups to have sub-prime mortgages; and the worldwide scientific community predicting that "global climate change will bring more intense and more frequent weather events in the not-too-distant future."He asked, "Why should Black people care about that? Two-words: Remember Katrina," he told the energetic audience.

Having served as president only about a year, Everett also vowed to address media-led stereotypes and misinformation about Black people, as well as the lack of racial minority ownership and "access to the new digital world."

Concluding, he said, "In other words, we cannot and will not stand idle while our youth, our communities, our people stand at the crossroads."

Among the crowd were at least two dozen members of the Congressional Black Caucus, including Chairwoman Carolyn Cheeks Kilpatrick, civil rights leader Rev. Jesse Jackson Sr. and two former Joint Center leaders Eddie Williams and former Army Secretary Togo West, immediate past president. The audience cheered at the April 8 event when Everett announced that the center had raised a record-breaking \$1.6 million with this year's dinner - "and we're still counting."

U.S. Rep. Jim Clyburn, (D-S.C.), House majority whip, received the center's top honor, the Louis E. Martin Great American Award, named for its founder. Clyburn said his colleagues in Congress as well as the next president must work hard to close the disparities pointed out by Everett. "I am determined that we will not be the first generation of Americans to leave their children with fewer opportunities than we had," Clyburn said.

AARP CEO William D. Novelli was the recipient of the center's first Partnership Award, pledging to continue giving to the cause of research, and policy analyzing. "Americans fear that their children's generation will end up worse off than they are," Novelli said.

"If that happens, it would be the first time in American history... a big step backwards. We can't let it happen. And that's why our partnership with the Joint Center is so important - it plays a critical role in helping our nation's leaders understand how key issues impact the African-American community."

The recording of Black political and economic thought and progress has been the hallmark of the center since its founding in 1970. A recent Joint Center survey of likely Black voters in the Democratic Primaries found that the war, healthcare, jobs/economy and education, were foremost on the minds of African-Americans going to the polls.

Everett pledged to focus the Joint Center's work on improving the prospects of young people of color, whom he described as "a generation at the crossroads."

I firmly believe that America needs the Joint Center now more than ever. We are going to deliver for America, through research, partnerships and policy reform recommendations. That's what my presidency at the Joint Center is gong to be about. And I welcome and thank you for joining in these

Everett said he sees the massive financial support as a sign of readiness by the community.

"It is a clear signal that America is ready to confront the difficult social and economic challenges that face our nation and our communities. And they want strong policy institutions to step up and focus on solutions," Everett said. "We accept and embrace our responsibility to increase the Joint Center's innovation and effectiveness in putting the concerns of communities of color and solutions to their problems at the very top of the nation's policy agenda."

disputed the charges and pegged them as politically motivated. Raines' attorney called Lockhart "a fatally biased regulator" and asked a federal appeals court to remove him

Spencer "was recognized as an outstanding controller for Fannie Mae where she conducted her duties with the highest integrity," her attorney, David Krakoff, said in a statement. "Ms. Spencer maintained throughout this action that the OFHEO reports and allegations had no merit."

Raines and Howard were swept out of office in December 2004 in the accounting fiasco at Fannie Mae. Two years later, the company announced a restatement for 2001 through June 30, 2004, that erased \$6.3 billion in previously reported profit.

Raines' total compensation from 1998 through 2004 was \$91.1 million, including some \$52.6 million in bonuses, according to OFHEO. Howard earned \$30.8 million during the period, including \$16.8 million in bonuses; Spencer received \$7.3 million, of which some \$3.5 million was bonus money.

Fannie Mae paid a record \$400 million civil fine in a settlement with OFHEO and the Securities and Exchange Commission in May 2006. It also agreed to make top-tobottom changes in its corporate culture, accounting procedures and ways of managing risk

Last November, Freddie Mac's former chief executive, Leland Brendsel, agreed in a settlement with OFHEO to pay \$2.5 million in fines to the government, give back \$10.5 million in salary and bonuses to the company and waive claims against the company for compensation worth \$3.4 million. Freddie's accounting scandal erupted in June 2003 when the McLean, Va.-based company said it had misstated earnings by \$5 billion between 2000 and 2002 - artificially inflating results in some periods, while reducing them in others.
