tests.

"While I was incarcerated, I was Inga," she said. "There was no Christian Louboutin boots; there was no Fendi bags. It was just me. I had no nails on. It was just literally me in the flesh. I guess that was the hardest part, just even with Foxy trying to find Inga."

With a new album on the way and her legal troubles mostly behind her, Brown said she was feeling positive and had learned from her mistakes. "I feel really good about my growth, and I feel change is the essence of

maturation," she said. "And I feel that I went through an enormous change, and I'm really excited. I've definitely learned [from my past mistakes]. Just having better judgment."

And though she served her time and didn't complain about the conditions, the rapper still couldn't help feeling that she might have gotten the Foxy Brown sentence and not the Inga Marchand one. "If you really, really, really look at the situation," she said. "I did not deserve a sentence that harsh. I really didn't."

Brown became the first

female rap artist to debut at No. 1 on the Billboard 200, the U.S. pop chart encom-

passing all styles of music, with her 1999 album "Chyna Doll."

### CENTRAL CITY INTERMODAL TRANSPORTATION TERMINAL RFSOQ #018-08

The Regional Transportation Commission of Southern Nevada (RTC) is soliciting Statements of Qualifications for a Construction Manager at Risk (the Applicant) to perform the Preconstruction and Construction Management Phases of the RTC's Central City Intermodal Transportation Terminal Project (the Project).

1. The Project is an intermodal facility that will include a 13,000 square foot office building, a 7,500 square foot transit terminal, 17 on-site bus berths, and approximately 3 staging positions. The facility will be home to the RTC's premier transit services, including the Deuce double deck vehicles and the ACE rapid transit vehicles.

2. The estimated cost of the Project is \$10 - \$12 million.

3. At a minimum, the RTC expects the firm selected as Construction Manager at Risk to perform the following preconstruction services:

- (a) Review and recommend revisions, if appropriate, to the Project master schedule, construction budget, and permitting plan;
- (b) Review the design documents and other construction documents and make recommendations as to value engineering; constructability, suitability of materials and equipment; scheduling, time, methods, and sequence of construction; and the clarity, consistency, and coordination of documentation;
- (c) Perform periodic detailed cost estimates for the entire construction and for phases or portions of the work as directed by the RTC, and work with the Project designer to reconcile differences;
- (d) Perform detailed cost estimates and value engineering analyses during the design phase of the Project and work with the Project designer to reconcile differences;
- (e) Develop a detailed critical path method schedule identifying all design activities, permits, and all other actions required to be completed before construction can begin; and
- (f) Develop a system for tracking Project costs and cash flow.

4. The preconstruction phase of the Project will commence immediately following contract award to the selected Applicant and is anticipated to extend until May 2009. The construction phase of the Project is anticipated to commence in June 2009, with a target date for completion of construction of June 2010.

5. The RTC intends to issue its Request for Statements of Qualifications on or about April 24, 2008. A pre-submittal informational meeting will be held on May 6, 2008 at 9:30 a.m. in conference room #108 at the RTC Administration Building, 600 S. Grand Central Parkway, Las Vegas, NV 89106. Statements of Qualifications must be submitted to the RTC no later than 3:00 p.m. (Pacific Time) on May 28, 2008.

6. The Statement of Qualifications must comply with all requirements of Senate Bill 201 (2007).

7. In order to participate in this Project, the Applicant must be qualified to bid as provided in Senate Bill 201 and must not have been disqualified from being awarded a contract pursuant to NRS 338.077, 338.13895, 338.1475, or 408.333.

9. The following factors, with the indicated relative weights, will be used by the RTC to evaluate the Applicants who submit a Statement of Qualifications for the Project:

Evaluation Criteria	Weight
1. Qualifications and experience.	40%
2. Staffing plan/structure of team.	30%
3. Preliminary project management and work plan.	20%
4. Financial capacity.	10%

10. On the basis of its evaluation of the Statements of Qualifications received, the RTC will determine which Applicants are qualified, and those qualified Applicants will be asked to submit a proposal in response to the RTC's Request for Final Proposals.

The successful respondent shall cooperate with the RTC in meeting its commitments and objectives with regard to ensuring non-discrimination in the award and administration of U.S. DOT assisted contracts and shall use its best efforts to ensure that barriers to participation of DBEs do not exist.
