The "Fastest Man in Football" was next. It was the prolific cornerback Darrell Green. He was only 173 pounds, but was fierce and undeniable during his tenure with the Washington Redskins.

Introducing Darrell was his proud son, Jared. Jared said that his father was his "provider, protector and a teacher about morals and integrity and I love him so." Darrell took to the podium and acknowledged his fine son.

Also, he addressed his three daughters and lovely wife while he proudly proclaimed his 23 years of faithfulness to her. Oh, it was a proud day for Black fatherhood Senator!

The last Black inductee was the ultimate Washington Redskins wide receiver Art Monk. Introducing him was James Arthur Monk Jr. — his articulate son. His son stated in the introduction, "I want to tell you how great a man he is outside of being a football player. I'm so proud to be living a life of 'me and dad'."
