# **Urban League gets Microsoft millions**

CHICAGO (NNPA) -Microsoft understands the importance of technology job skills in today's downsizing economy.

In November, reports showed that the U.S. shed about 533,000 jobs and unemployment is at 15-year high at 6.7 percent. People who once felt their jobs were secure are now seeing them slip away. And according to reports by the U.S. Labor Department jobless figures for African-Americans totaled a staggering 10.6 percent in November, compared to 4.3 percent for White Americans. Now more than ever, during these economically rough

times, it's important that people have the skills necessary to stay competitive. -

"It's our goal at Microsoft to make sure that everyone has access to develop the technology skills needed to compete in today's work environment," said Shelley Stern, Microsoft's citizenship director for the Central Region.

"One of the Chicago Urban League's goals is to connect low-wage workers and people with little or no work experience to good-paying jobs," said Cheryle R. Jackson president and CEO, Chicago Urban League.

"We provide access to training in fastgrowing fields

such as information and communications technology. In Chicago's underserved communities, business owners and aspiring entrepreneurs need support to drive innovation and create economic opportunities for themselves and jobs for others."

The organization has worked to address these chalthrough lenges projectNEXT, which is the Urban League's economic development program launched in 2007. The Urban

League is providing entrepreneurship and workforce development programs, expanding commercial real-estate development opportunities, and advocating for improved educational resources in the African-American community.

Through its Unlimited Potential grant, Microsoft has donated more than \$2.6 million in software and cash to help fund digital literacy and computer skills programs within projectNEXT.

cious, unjustified and unreasonable, and so outrageous as to be none endurable in a civilized society," the lawsuit says. Police put Eller at risk of great bodily harm and did not seek or provide him with medical treatment, the lawsuit adds. All of the squad cars involved had videotaping equipment and a deputy chief ordered that the tapes be retrieved following Eller's arrest, the lawsuit claims.

But it says the tapes turned over to the defense don't show what happened, and alleges the officers "acted or may have acted separately or in concert, to conceal, divert or destroy potential evidence of the excessive force."

Garcia described the lawsuit's claims as tactics to "distort the facts." "Carl had been drinking, driving erratically, and he attacked two officers," he said.

Garcia said that while some squad cars responding were equipped with cameras, the car belonging to the first officers on the scene did not.

In Mississippi, 46.9 percent of Black males are uninsured, compared with 25.3 percent of White males. And, 23.5 percent of Black males in the three-state region don't have a high school diploma. Citing U.S. Bureau of Justice statistics, the report says that Black male homicide rates were 8.3 times higher than for the Final Call. White males. Black-on-Black offenses accounted for 94 percent of the homicides between 1976 and 2005.

Who will stand up for the South?

Crothers cited organizations such as the New Yorkbased 21st Century Foundation, as a model of what can be done in the Mid South to address the problem.

The 21st Century Foundation provides grants for strategies and programs geared toward issues affecting Black
