Cowboys release troubled Adam 'Pacman' Jones

IRVING, Texas (AP) -Troubled cornerback Adam "Pacman" Jones must look elsewhere in the NFL for another chance. The Dallas Cowboys are done with him.

Jones was released Wednesday by the Cowboys following a turbulent season in which he was suspended six games for an off-field scuffle and made little impact on the field.

Jones, expected to give the Cowboys a boost on defense and special teams, had no interceptions and averaged just 4.5 yards per punt return. His release will become official Feb. 9, the first day NFL teams can make waiver requests.

"He was surprised, and I think he was obviously somewhat hurt," said Worrick Robinson, Jones' Nashville, Tenn.-based attorney. "At the same time, he understands the business behind what is happening here."

Jones' attorney added he expects the cornerback will be back with some team in

get back on the field," Robinson said.

Cowboys spokesman Rich Dalrymple declined to comment on the team's decision and said owner Jerry Jones was unavailable. Coach Wade Phillips did not immediately return a message left by The Associated Press.

The Cowboys traded for despite Jones the cornerback's suspension for the 2007 season after multiple off-field incidents while with the Titans. He was given another chance and cleared to play in 2008 by commissioner Roger Goodell.

But on Oct. 7, Jones got into a scuffle with a bodyguard who was part of a team-employed security de-

A week later, Goodell suspended the cornerback indefinitely, which eventually turned into a six-week suspension. Jones missed a seventh game later in the season with an injury.

The 25-year-old Jones spent part of his time away from football taking part in "He is young. He has a lot an alcohol rehabilitation pro-

"He was a young man who needed the opportunity to be in treatment, and he got the treatment he needed," Robinson said. "He came out of there a better person and a healthier person because of that."

Robinson said he did not think Jones' suspension was a factor in the Cowboys' decision to release the cornerback.

Ex-Viking: Min cops abused

MINNEAPOLIS (AP) -Vikings great Carl Eller sued the Minneapolis Police Department on Monday, alleging officers violated his civil rights, used excessive force and concealed videotape evidence when they subdued him during an arrest last April.

The Hall of Fame player was arrested after he allegedly drove through a stop sign and narrowly missed hitting a squad car. Officers followed him home, where they say he became combative. He was charged with fourthdegree assault and making terroristic threats, which are felonies, and driving while impaired and refusing to take a chemical test for alcohol, which are gross misdemeanors.

Police dismisssed the lawsuit as baseless. The suit, filed in federal court, seeks damages of more than ficers "maliciously and/or \$75,000, plus punitive dam-

"All of this truly could have been prevented if Carl had stopped at the initial interaction with police," said Sgt. Jesse Garcia, a police spokesman.

Eller is to go on trial on the criminal charges this week in Hennepin County District Court. Prosecutors have said that if he's convicted, he'll likely face some combination of up to a year in jail and probation.

The 66-year-old former defensive end has acknowledged his struggles with substance abuse. He pleaded guilty to driving under the influence in 2006. He became a treatment counselor and has spoken publicly to groups about the problems of chemical dependency.

The lawsuit alleges that officers used excessive force when they struck Eller on the head three times with a large flashlight, used a choke hold and shocked him multiple times with two Taser stun guns, even after he had lost consciousness.

The suit contends that ofrecklessly" assaulted Eller because he is Black, and did so as part of a "tacit agreement or conspiracy" to violate the rights of African-Americans in Minneapolis.
