Biographical Note

Nevada Assemblyman Robert "Bob" Price was born in DeLand, Florida in 1936. Price, an electrician by trade, was a member of the International Brotherhood of Electrical Workers Union Local 357 in Las Vegas for 42 years. He served as a Democrat from Clark County in the Nevada Assembly, from 1975 to 2001, in three special sessions and 14 regular sessions. Price served as a member of the Interim Finance Committee from 1987 to 1995 and from 1997 to 2001; he chaired the Legislative Committee on High-Level Radioactive Waste and the Assembly Committee on Constitutional Amendments; and he was Vice Chairman for the Assembly Committee on Elections,

Procedures, and Ethics. He also served as the chair of the Assembly Taxation Committee and as a strong supporter of worker rights.
