## Biographical Note

---

Registered land surveyor and real estate broker Gilbert Buck was born in Kansas City, Kansas in 1927. After serving in the United States Army during World War Two, he moved to Southern

California and worked with several engineering firms. Buck relocated to Las Vegas, Nevada in 1968 and worked as a surveyor and land planning consultant. He had an unsuccessful campaign as a Republican candidate for governor of Nevada in 1974. Buck attended the University of Nevada, Las Vegas (UNLV) from 1977 to 1980 and later conducted seminars on buying and developing raw land. He was active in many local organizations and in 1977 was awarded "Real Estate Broker of the Year" for Las Vegas, Nevada. Gilbert Buck passed away in 1986.
