| Abstract: | This collection is comprised of research files dating from approximately 1980 to 2021 created by Boulder City Nevada, Dennis McBride, primarily in support of his book, <i>Out of the Neon Closet: A History of Gay Las Vegas</i> on the history of the lesbian, gay, bisexual, gay, transgender, and queer (LGBTQ) community in Southern Nevada. Materials in this collection also include ephemera and clippings documenting LGBTQ establishments and organizations in Las Vegas, biographies of individuals, and other issues pertinent to the LGBTQ community. This collection also includes some materials about the LGBTQ community and their issues in Northern Nevada. The collection represents McBride's overall efforts to document and preserve the history of the LGBTQ community in Nevada. |

Biographical Note

Dennis McBride was born on January 13, 1955 and grew up in Boulder City, Nevada. He received both his BA and MA in English Literature from the University of Nevada, Las Vegas (UNLV). He

is well-known as an expert in the history of Hoover Dam and has published several histories of Boulder City. His books include *In the Beginning: A History of Boulder City, Nevada*, *Building Hoover Dam*, *An Oral History of the Great Depression* (with Andrew Dunbar), and *Midnight on Arizona Street: The Secret Life of the Boulder Dam Hotel*. McBride is also an authority on Nevada's lesbian, gay, bisexual, transgender, and queer (LGBTQ) history. He has chronicled and collected the history of the LGBTQ community in Las Vegas since the late 1970s. He has worked as a curator of historical collections at the Boulder City Museum and Historical Society, UNLV Libraries Special Collections, and the Nevada State Museum. He was appointed Director of the Nevada State Museum in 2012.

Scope and Contents Note

The Dennis McBride Collection on LGBTQ Las Vegas (approximately 1980-2021) is comprised of research files about the history of lesbian, gay, bisexual, transgender, and queer communities and LGBTQ issues that were created by Boulder City, Nevada native, Dennis McBride in support of his book *Out of the Neon Closet: A History of Gay Las Vegas*. Files include biographical sketches of notable personalities (political, religious, celebrity, and activist) in Las Vegas, information on LGBTQ organizations (political, social, and civic), and material documenting significant events primarily in the Las Vegas LGBTQ community, but also including Northern Nevada. Additional files focus on associations and initiatives that have been important to the greater LGBTQ community from the 1980s to 2017 such as AIDS/HIV, gay marriage rights, and discrimination. The collection represents McBride's overall efforts to document and preserve the history of the LGBTQ community in Nevada.
