The Southern Nevada Association of Women Attorneys (SNAWA) is a nonprofit organization established in 1979 to offer support, networking opportunities, and guidance for personal and professional development to women attorneys in Southern Nevada. SNAWA hosts various social events throughout the year for the legal community in addition to regular monthly luncheons. SNAWA also organizes continuing legal education (CLE) events and seminars. Proceeds from
