Historical Background

The Southern Nevada Coalition of Concerned Women, Inc. (SNCCW) was formed by Betty Brewer, Gloria Hewitt, and Beverly Stewart who were concerned with the many issues confronting African American women in Southern Nevada. On March 28, 1996 the group named themselves the Southern Nevada Coalition of Concerned Women and developed a mission statement. The group grew over the next several years and held many charity luncheons and participated in other

charity events around the Las Vegas, Nevada area. On January 28, 2017 the SNCCW dissolved due to loss of community interest and participation.
