Abstract:	Oral history interview with Hattie Canty conducted by Claytee White on February 27 and June 17, 1998 for the Las Vegas Women Oral History Project. In this interview, Hattie Canty recalls moving to Las Vegas, Nevada in the late 1960s and working as a maid for the Thunderbird Hotel and Casino and later the Maxim Hotel and Casino. Canty discusses her tenure as the Culinary Union Local 226 President during which she faced several labor challenges and went to jail at least six times while striking. Scope and Contents Note

Oral history interview with Hattie Canty conducted by Claytee White on February 27 and June 17, 1998 for the Women's Research Institute of Nevada (WRIN) Las Vegas Women Oral History Project. In this interview, Hattie Canty recalls moving to Las Vegas, Nevada in the late 1960s and working as a maid for the Thunderbird Hotel and Casino and later the Maxim Hotel and Casino. Canty discusses how the Culinary Union Local 226 provided her with health benefits and a pension and taught her how to fight for her rights. Canty also recalls when she would walk picket lines on her days off, and how championing to obtain better salaries for women and to increase the number of African Americans in high-paying positions in the casino industry. Hattie also spoke about being elected to President of the Culinary Union in 1990, 1993, and 1996. She recalls her tenure as the Culinary Union President during which she faced several labor challenges and went to jail at least six times while striking. Finally, Hattie discusses how she influenced contract negotiations for the downtown hotels, improved race relations among workers, involved more members in union operations, and implemented the Culinary Training School.
