Abstract:	Oral history interview with Steve Johnson conducted by Fred Reagan on March 20, 1978 for the Ralph Roske Oral History Project on Early Las Vegas. In the interview, Johnson discusses his exposure to African American racial discrimination and segregation in Las Vegas, Nevada during the 1950s to the 1970s. He discusses these experiences in markets, theaters, casinos, employment, and in common social interactions. Johnson also discusses the slow progression of social acceptance to racial integration and African Americans entering professional fields.

## Scope and Contents Note

Oral history interview with Steve Johnson conducted by Fred Reagan on March 20, 1978 for the Ralph Roske Oral History Project on Early Las Vegas. In the interview, Johnson discusses his exposure to African American racial discrimination and segregation in Las Vegas, Nevada during the 1950s to the 1970s. Johnson goes through the city's history, focusing on the changes in attitude of both black and white communities. Johnson articulates the frustrations and liberation of the African-American community in connection to the types of employment available, segregation in the Westside and in public establishments, and the mobility in society afforded by education, or lack thereof. Johnson shares his personal growth and education as a juvenile counselor. Johnson spends the last third of the interview speaking about the Civil Rights Movement, drugs in black communities and the need to chip away at the prevalence of racism.
