## Scope and Contents Note

Oral history interview with Daniel A. Moore conducted by Norwood Germany Jr. on March 03, 1979 for the Ralph Roske Oral History Project on Early Las Vegas. Moore begins by speaking about his move to Las Vegas, Nevada from Utah in 1952, his education and his work in construction and at the Las Vegas McCarran Airport. Moreover, Moore speaks about his involvement with church and his recreational hobbies such as bowling. Moore also spends time speaking about the African American population in Las Vegas, the jobs available to them, racial tensions in his young adulthood versus his children's experiences, and the segregation of black communities into the Las Vegas Westside. Lastly, he talks about the city's growth, tourism and the economy, the

development of different shopping centers and malls, and the city's law enforcement. Digital audio and transcript available.
