Oral history interview with Valerie Wiener conducted by Barbara Tabach on January 20, 2015 for the Southern Nevada Jewish Heritage Project. She shares memorable insight into the life of her father, Louis Isaac Wiener, Jr., an accomplished attorney and business man who represented the infamous Benjamin "Bugsy"

Siegel during the construction and opening of the Flamingo Hotel and Casino in 1946. Throughout Wiener's interview, she highlights the traditions of the small, but growing Las Vegas Jewish population in the 1960s.
