Oral history interview with Fluff LeCoque conducted by Joyce Marshall on May 05, 1997 for the Women's Research Institute of Nevada (WRIN) Las Vegas Women Oral History Project. LeCoque discusses the history of Las Vegas, Nevada's entertainment industry. Fluff discusses working as company captain and principal dancer at the Moulin Rouge in Hollywood, California and joining a touring company of Hollywood Extravaganza as principal dancer, choreographer, and ballet mistress. LeCoque retired from dancing in 1970, but recalls being lured out of retirement by Donn Arden to become company manager of *Jubilee* at the new MGM Grand Hotel (later renamed Bally's).
