He speaks to the importance of planners and landscape architects on Southern Nevada's conservation goals and efforts. Zunino traces the evolution of landscape architecture in casino design. He credits the work of Steve Wynn and Lifescapes International for creating The Mirage, which generated in Las Vegas, a newfound appreciation of
