She spends some time talking about what life was like backstage, relations between the girls, and meeting celebrities, her first experience with topless dancing in <i>Lido de Paris</i> , and how the backstage dressing areas were assigned and the difficulty of fast changes between sets. Later, she talks about things that can go wrong, from forgetting choreography to the more serious issue of the HIV/AIDS epidemic that swept through the shows in the 1980s.
