## **Biographical Note**

Henry C. Wieking was born January 5, 1906 in Alameda, California. He worked as a draftsman in Oakland, California until 1929, when the United States Bureau of Reclamation hired Wieking to work in Las Vegas, Nevada. He moved to Las Vegas in approximately September of 1929, and he

worked on the construction of Hoover Dam (Boulder Dam) and the reconstruction of the Las Vegas Mormon Fort. Wieking died May 25, 1998 in Pleasant Hill, California.
