Kodey retired from the *Review-Journal* in

1995. Wayne and his wife, photographer Geri Kodey, ran a local photography equipment store, Casey's Cameras, from 1995 to 2013. As of 2026, Wayne C. Kodey resides in Las Vegas, Nevada.
